FULL FAMILY: \$243.06 (TAX INCLUDED)

MEMBERSHIP INCLUDES ALL CLUB PRIVILEGES FROM GOLF TO CLUBHOUSE. INCLUDES UNMARRIED CHILDREN UNDER THE AGE OF 21 LIVING AT HOME OR FULL-TIME STUDENTS.

JUNIOR FULL FAMILY: \$211.81(TAX INCLUDED)

MEMBERSHIP INCLUDES SAME AS FULL FAMILY BUT RESERVED FOR MEMBERS BETWEEN THE AGE OF 19-37. UPON MEMBERS 38TH BIRTHDAY THIS MEMBERSHIP WILL CONVERT TO A FULL FAMILY.

SINGLE ADULT: \$173.61 (TAX INCLUDED)

MEMBERSHIP INCLUDES PRIVILEGE FROM GOLF TO CLUBHOUSE, ONE INDIVIDUAL MUST BE A SINGLE MEMBER HOUSEHOLD.

OUT OF CITY: \$136.94 (TAX INCLUDED)

MEMBERSHIP INCLUDES ALL CLUB PRIVILEGES FROM GOLF TO CLUBHOUSE FOR THOSE THAT RESIDE OUTSIDE THE PLAINVIEW CITY LIMITS. THIS TYPE OF MEMBERSHIP DOES NOT HAVE VOTING PRIVILEGES AND IS EXEMPT FROM FOOD MINIMUM. PROOF WITH UTILITY BILL OR DRIVERS LICENSE.

YOUTH: \$27.50 (TAX INCLUDED)

MEMBERSHIP INCLUDES ALL CLUB PRIVILEGES FROM GOLF TO CLUBHOUSE ONLY FOR YOUTH 18 AND YOUNGER. IT ALLOWS THE YOUTH UNLIMITED GREEN FEE AND ACCESS TO THE POOL AND CLUBHOUSE.

FULL FAMILY SOCIAL: \$88.00 (TAX INCLUDED)

MEMBERSHIP INCLUDES ALL CLUBHOUSE PRIVILEGES AND INCLUDES UNMARRIED CHILDREN UNDER THE AGE OF 21 LIVING AT HOME OR A FULL-TIME STUDENT. IT EXCLUDES ANY GOLFING PRIVILEGES.

SINGLE SOCIAL: \$49.50 (TAX INCLUDED)

EXTENDS ALL SOCIAL MEMBERSHIP BENEFITS TO ONE INDIVIDUAL.
